How are individual needs assessed? How do we include other needs with the assessment? Resource Allocation

How do needs turn into services and funding? Service Planning and Delivery

How is the service plan developed, used, and checked? Payment Model

How does the state pay for services?

Accountability

How does the state track the services provided and money spent?

What Does the SIS-A Ask?

SIS-A 1st Edition Sections:

Section 1: Exceptional Medical and Behavioral Support Needs

- Asks questions about extra support needed for medical and behavioral needs.
- There are 18 questions for medical support needs.
- There are 12 questions for behavioral support needs.

Section 2: Support Needs Index

Asks about needs for 57 different life activities using three measures:

- *Frequency* how often you need the support
- *Amount* how much time it takes to get the support
- *Type* the kind of support you need

The Support Needs Index contains six subsections:

- Home Living Activities
- Community Living Activities
- Lifelong Learning Activities
- Employment Activities
- Health and Safety
- Social Activities

Section 3: Supplemental Protection and Advocacy Scale

• Asks about activities an individual can do to protect and advocate for themself.
