Agency of Human Services (AHS) Accessibility Committee

Agency of Education (AOE)

- Met monthly with AOE on how to improve Request for Proposal (RFP) process for upcoming school years.
- Provide ongoing support for School Age Subcommittee of DHHDB Advisory Council.
- Consult monthly with new POC (Cassie Santo) on regular basis.
