**Re:** Guidance to Employers to Pay People Living in the Home During the COVID-19 Pandemic

This document provides guidance to independent employers under the Attendant Services, Choices for Care, and Traumatic Brain Injury programs.

The COVID-19 pandemic has created an urgent need to maintain physical distance and aggressively reduce person to person contact. This will help to reduce the spread of the virus and reduce the impact on our healthcare system.

As part of Vermont's strategy to address the COVID-19 challenges, one goal is to provide more flexibility in paying direct care workers living in the home. With this flexibility, we are providing a blanket variance to allow employers to temporarily pay people ages 16-17, parents, spouses, guardians, and people who serve as employers.

The changes below are effective as of March 13, 2020, the date that Vermont declared a State of Emergency. These changes will expire at the end of the COVID-19 emergency.

Please also note that the public health situation is changing, and guidance may change as a result.

Guidance for Independent Employers:
