- 5. Provide a brief explanation of why you (the candidate) are interested in serving on the Older Vermonters Act Working Group:

In 1997 I was hired as a Public Guardian by DAD (predecessor to DAIL), one of 4 Public Guardians for the elderly (later the public guardians for the elderly and those for the developmentally disabled were combined into one agency, but that was after I had left the position). I was assigned to cover Bennington, Rutland and Addison counties, as well as elsewhere as needed. This was my first exposure to elderly services, though my mother had been receiving care for several years for dementia. I had retired from a career in the federal probation system, and recognized that the skill set I had developed there (advocacy for the disenfranchised; interaction with the social services systems; operating within the court system; etc.) was completely transferable to working with this new population. Fortunately for me, the folks who oversaw the Public Guardians recognized that as well.

In 1999, my then 83-year old friend and neighbor in Proctor asked for my help. She owned her home, but had insufficient income to meet her needs, and was fearful that she would be forced to leave her home of 40+ years, and the town in which she had lived her entire life. I agreed to see what I might be able to find to help her, and discovered the federal government's reverse mortgage programs. At the time, no one in the state of Vermont was offering this product, but it seemed to meet my friend's needs perfectly. I talked my way into a job as a reverse mortgage originator, covering the whole state of Vermont (the sole person in that position for the first 4

years), a job I held until 2016. In that capacity, I met hundreds of older Vermont homeowners and families and learned a great deal about their experiences of aging in Vermont.

After leaving the Public Guardian position, I also provided equivalent services for several people over the years, as Power of Attorney.

In addition, I served on the COVE Board for several years in the mid-2000s, and as the Windsor town representative on Senior Solutions' advisory group from 2016 to 2018. In that capacity I was also appointed to the DAIL Advisory Board in 2016, as the representative for southeastern Vermont, resigning those positions in April 2018 because I had moved back to Burlington after selling my house in Windsor.

While in Windsor, I also was a volunteer driver for Volunteers in Action, primarily providing transportation as needed for local area medical appointments, as well as volunteering with Senior Solutions' SHIP coordinator to offer Introduction to Medicare classes and assistance.

Recently, I have also been an AARP FraudWatch volunteer, with a program with significant emphasis on elder fraud.

Although I have lived in Chittenden County for about half of my tenure in Vermont, my work has always taken me throughout the state, and exposed me to situations from Canaan to Guilford, and Highgate to Pownal.

Most of my professional life has involved working with older adults. As the Volunteer Coordinator (1978-1981) and then Director of RSVP of Windham County (1981-2005), my work involved both interaction with older volunteers and with the service agencies at which they assisted.

Interested in issues and politics since my late teens, I served for twenty years as a State Rep from Brattleboro (1991-2010). Merging that experience and my years at RSVP, my seven years (2011-2018) as Executive Director of COVE (Community of Vermont Elders) allowed me to focus the advocacy skills gained as a Legislator on issues impacting older Vermonters.

My interest in older adult issues was enhanced by my involvement for several years with my mother's care, in partnership with my sisters and her live-in caregiver, until she passed away last September at the age of 99. That included an episode of abuse at a local nursing home, which culminated in the employee being put onto the registry.

While my residence is now in Washington County, my ties to Windham County run deep, and my interest in issues that affect older persons is even stronger now that I am in my late 60s. Serving on the Older Vermonters Act Working Group would enable me to continue work that has become a passion for me and to apply 45 years of experience to an exciting new project.

Thanks to my secure, friendly, helpful living environment, I am able to optimize my limited mobility and "pay forward" my good fortune.
