While we cannot guarantee that the items you need will be available, please know that the Vermont Department of Health is working hard to triage all resource requests across the state. This request form is the best way to add your organization's needs to the queue.

**Non-medical supplies:** Please note that provider requests for non-medical supplies that are essential but are not available locally (such as **hand sanitizer**, toilet paper, etc.) are addressed by the State Emergency Operations Center (SEOC), **after all local resources have been exhausted. Please send any requests for essential non-medical supplies to the SEOC via phone at (800) 347-0488 and they will connect you with available resources known to them, or add your organization to a waiting list as appropriate.**

**Volunteer coordination:** If you have a need for volunteers to help deliver the services your organization provides, contact the SEOC via phone at **(800) 347-0488** and they will determine available volunteer resources that may be able to assist. In addition, DAIL recommends that your organization reach out to the local emergency management directors in your areas to begin mapping out specific resource availability and shortages, if you have not already done so. A list of designated emergency management directors and their contact information, by town, is attached to this message.

**Personal Protective Equipment (PPE) Conservation Measures  
Contingency Operations  
SUMMARY**

Personal Protective Equipment (PPE) shortages have created challenges for health care providers worldwide. Vermont providers are also experiencing shortages of PPE.

On March 5, 2020, the U.S. Centers for Disease Control and Prevention provided guidance on PPE conservation measures available to health care providers. Based on current reports from providers in the state, the Vermont Department of Health considers that health care facilities statewide are operating in the Contingency Operations realm of PPE conservation.

Based on the CDC 'Checklist for Healthcare Facilities: Strategies for Optimizing the Supply of N95 Respirators during the COVID-19 Response' (see link below), the Vermont Department of Health recommends that all health care facilities and providers conserve PPE using all of those measures outlined in the Conventional Operations section of the 'Strategies for Scarce

Completion of this COVID-19 resource request form assumes facility implementation and practice of Contingency Operations Personal Protective Equipment Conservation (PPE) measures. PPE conservation measures are based in part on the CDC 'Checklist for Healthcare Facilities: Strategies for Optimizing the Supply of N95 Respirators during the COVID-19

Response': <https://www.cdc.gov/coronavirus/2019-ncov/hcp/checklist-n95-strategy.html> (published 03/05/2020).

All resource requests are made with the understanding that such resources will be used by facility staff and patients only. Safe, effective and ethical release of state resources is contingent upon complete and candid answers to all resource request questions. All resource requests will be prioritized based upon resource availability and provider need with the understanding that not all requests may be met.

Implementing these PPE conservation measures by health care providers will help reduce rates of PPE consumption and ease scarcity. Some health care providers may still face PPE shortages, which may increase risk of infection for providers. The Health Department has some limited supplies of PPE available to providers on a case-by-case basis.

*Release of any of the Health Department's PPE stocks will be made with the understanding that all of these Contingency Operations PPE Conservation Measures are already in practice.*
